### **Board Chair Report**

Ron Burton reflected on the past school year that had seen many challenges, including a protracted labour dispute at the start of the year and a recent change in leadership. The district has come together as a strong team. He thanked all staff and assured them they had the full support of the Board.

Vice-Chair Harman Pandher reflected on National Aboriginal Day, held on June 21. It had been a banner year for Aboriginal education in the district, including the signing of a new Aboriginal Enhancement Agreement and culminating in the Honouring our Youth ceremony. Mr. Pandher noted that education plays a key role in the process of true reconciliation based on mutual respect and understanding. Many of the recommendations of the Truth and Reconciliation Commission, specifically recommendations 62 and 63, were focused on education and he hoped the Board would fully support them.

Trustee Larry Hayes spoke of the passing of Anita Hagen a former Minister of Education and a former school trustee. He also mentioned that the district had celebrated its retirees from all employee groups earlier in the month and owed a debt of gratitude to them all.

### SchoolCash Online

Roy Uyeno, Assistant Secretary-Treasurer introduced Lynda Kerr, Accounting and Audit Officer. Ms Kerr outlined the SchoolCash Online e-payment system that permits students, staff and parents to make payments online. This easy-to-use and secure system has eliminated a significant amount of cash and cheques from the district's accounting processes and integrates seamlessly with the district's school-based accounting system.

Marlene Ciaburri, secretary at Armstrong Elementary, and Dave MacLean, Principal of Westridge Elementary School, shared their experience of the system and the impact it has had on their schools.

### Capital Project Bylaw No. 126895

Mr. Frank presented the pro-forma Capital Project Bylaw for the 2015/2016 Annual Facility Grant funding for the maintenance of school facilities. Total funding approved for the district is \$4,809,484, of which \$3,799,310 is to be funded through a capital grant. To access the capital grant funding the Board is required to adopt Capital Project Bylaw No. 126895 in the amount of \$3,799,310.
